#### **Finance**

This was a busy year on the finances front with significant grant funding activity on top of regular finances.

A big effort by the committee over the last 12 months has delivered significant improvements to the hall, setting it up for the future.

A team effort secured the funding and delivered the improvements.

The majority of improvements were grant funded with additional support from Market Fund of around £14,458.
